

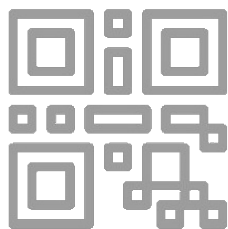
APSI COVID SAFETY PLAN

GENERAL HYGIENE AND SANITISATION

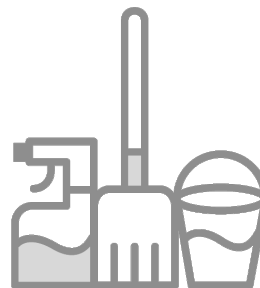


Each training room in East Perth campus has a sanitising station at the entrance and a SafeWA QR Code. When you enter the training room, please scan the QR code and use the hand sanitizer and sanitising wipes to wipe down the desks before and after use. Please bring your own laptop and drink bottle to class.

If you feel that you have a high temperature, please come to Building 1 Student Services to have your temperature check.

In addition, we are ramping up our cleaning schedule to disinfectant high touch areas throughout the campus.

Please remember do not come to campus if you are unwell or feeling ill. Please stay at home and follow the guidelines on RAT and PCR tests. Please email to service@apsi.edu.au or call 6365 4386 as soon as possible so that we can inform the trainer. In most instances, the trainer will send you a ZOOM link for you to attend theory classes.



We are required to maintain an accurate record of **CONTACT TRACING** people attending all classes in all training locations premises. Besides signing on the attendance sheet, please remember to use the Safe WA app in each training location by scanning the QR code upon entry.

MASKS

Masks are required upon entry to campus and must be worn at all times while on campus or in any training locations. Masks can only be taken off when you are eating or drinking. Please work with your trainers and adhere to this rule.

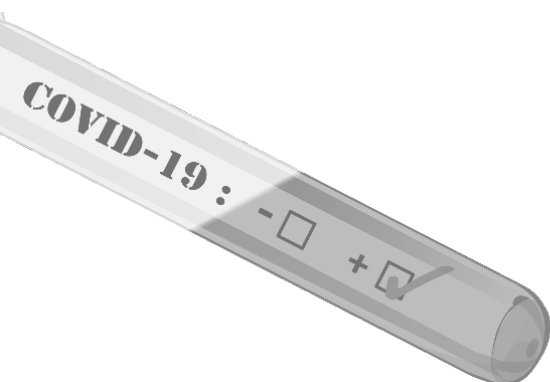
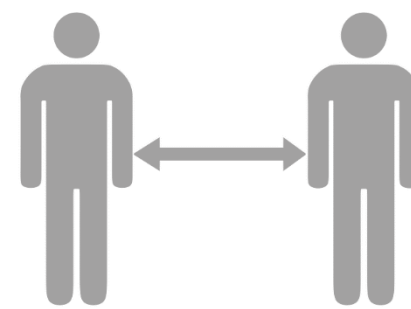


All staff and students **PROOF OF VACCINATION** must be double vaccinated before they can come to campus and all training sites. Copy of your vaccine record must be kept in our file. Please email your updated vaccine certificate to student services if you have not done so.



PHYSICAL DISTANCING

Physical distancing remains one of the most effective methods of reducing the spread of viruses. Level 2 measures are currently in effect for all of WA, thus the 2sqm rule must be observed when you are on campus or in any training locations. Whilst not always practicable in some practical training sessions, we are encouraging everyone to uphold the 2sqm rule and avoid crowding.



If you are a **CONFIRMED POSITIVE CASE** confirmed positive case after a PCR test, please self-isolate until a negative PCR test is returned. If you are a [close contact](#), please go to get tested immediately and self isolate until a negative PCR test result is returned.
